2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF ABACO PALMS PROPERTIES, and assume full responsibility for my participation.
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence of participation, I will remove myself from participation and bring such to the attention of ABACO PALMS PROPERTIES immediately.

(initial) I do hereby agree that no one under the age of 14 shall operate this boat under any conditions.

(initial) I do hereby agree that children between the ages of 14 and 18 years of age may only operate this boat under the direct supervision of an adult, aged 25 years or older. And I do hereby state that under direction supervision means that the adult must be in the boat at
